### PAJE

[Lawyer Monthly](#), [Public Law Today](#) - Further reports appear that lawyers from underrepresented groups will be better supported to become judges following the launch of a new online education programme, the Pre-Application Judicial Education programme (PAJE).

Developed using government funding, the programme is the first joint initiative from the Judicial Diversity Forum (JDF), which aims to encourage diversity within the judiciary.

JDF is made up of the Judiciary, Ministry of Justice, Judicial Appointments Commission, The Bar Council, The Law Society and the Chartered Institute of Legal Executives.

**Chair of the Bar, Richard Atkins QC**, said: "PAJE is an important initiative for the judiciary and is based on a concept which the Bar Council and its Equality & Diversity and Social Mobility Committee has been keen to progress. It forms part of a [wider offering](#) from the Bar aimed specifically at supporting barristers seeking a career as a judge. To see PAJE come to fruition in conjunction with the judiciary and other branches of the legal profession is a positive step towards a more diverse judiciary which reflects the society it serves.

### Immigration

[Times Online](#) – Times Online reports on the Bar Council's consultation submission to the Law Commission on immigration rules.

The Times reports: "Britain could face another Windrush scandal unless immigration rules are urgently reformed, the Bar Council of England and Wales has warned the Law Commission. The laws are badly drafted and confusing, barristers told the body that advises the government on legal reforms. They said that overly

complicated rules were a factor in the Windrush case that increased the risk of people with the right to remain in Britain being incorrectly detained or removed.”

The Times says that the Bar Council described the current rules as “impenetrable”.

## CPS

[The Guardian](#), [The Times](#), [Law Society Gazette](#) – The national media report that the [Crown Prosecution Service](#) needs an urgent injection of cash to pay for the “explosion” in its digital disclosure workload, the union representing its lawyers has said.

A “Manifesto for Justice” has been launched by the FDA, formerly the First Division Association, in the wake of a row over how police and the CPS handle rape and sexual assault complaints.

The document also calls for improved resources for the CPS, a ban on further cuts to legal aid and “competitive” pay to recruit and retain prosecutors.

The four key demands are supported by the legal profession’s main membership bodies – the Bar Council and the Law Society.

Richard Atkins QC, Chair of the Bar, is quoted. He said: “The failure to increase rates of pay for publicly-funded lawyers, both prosecution and defence, is nothing short of a scandal.”

## Bar Mock Trials
